

Attached is a proposed schedule for the next two weeks of hearing, showing the City's proposed schedule of its witnesses as well as the best information we have from the Appellants as to their remaining witnesses. To accommodate various scheduling constraints, Appellants have consolidated their remaining testimony on August 20-21, with the City agreeing to allow Appellants one additional hour on August 22 before the City resumes its case in chief.
