and Administrative Services


On September 13, 2018, a prehearing conference was held regarding this matter. Represented at the conference were the Appellant, Doug Waun ("Appellant") by Michael Fandel and Drew Duggan attorneys-at-law; and the City ("City") was represented by Stephanie Dikeakos attorney-at-law.

During the prehearing conference the parties identified a schedule for final witness and exhibit lists and exchange of exhibits, and a hearing schedule. The following matters were discussed and resolved:

1. Each party shall file with the Office of Hearing Examiner, and serve on the other party, their respective witness list¹ and exhibit list, no later than 5:00 PM on September 24, 2018. Each party shall serve the other party a copy of each of the exhibits listed on its respective exhibit list, no later than 5:00 PM on September 24, 2018. (Note to all parties: Exhibits are not to be filed with the Office of the Hearing Examiner electronically or in hard copy. Parties are not required to provide copies of an exhibit to another party if the other party is known to possess a copy of the exhibit. Parties must be prepared to provide a copy of any exhibit to be introduced at the hearing in hard-copy form to the Hearing Examiner.)

The hearing in this matter is scheduled to be held on October 1, 2018, beginning at 9 AM in the Office of Hearing Examiner, Hearing Room 4000, 700 Fifth Avenue, (Seattle Municipal Tower, 40th Floor) Seattle, Washington.
