
**NOTICE ON CORRUPTED  
AUDIO RECORDING**

Appellant Save Madison Valley, a citizens' group, ("SMV" or "Appellant") has filed a motion seeking restoration of corrupted portions of the electronic audio recording. This notice acknowledges the inadvertent corruption of the record and provides information on remedies.

The appeal hearing was held on December 10, 11, 12, 13, and 17, 2018 and February 5 and 6, 2019, before the Deputy Hearing Examiner ("Examiner"). On Days 2 and 3 (December 11 and 12) there are portions of the audio mp3 that are inaudible, due to the fact that two channels are malfunctioning in the Office of Hearing Examiner recording equipment. It is possible to listen to the recording through the "For The Record" ("FTR") audio player application by turning off those two channels. To do so, one must obtain a CD copy of the FTR files from the Office of Hearing Examiner. To listen to the CD, download the FTR Player. The download is free and can be found at <https://www.fortherecord.com>. Once downloaded and opened, manually turn off each channel on the right side of the playback panel and use trial and error until the functioning channel(s) is found.
