

**ORDER GRANTING
TREEPAC'S REQUEST
FOR DOCUMENTS**

On April 1, 2019, the Deputy Hearing Examiner ("Examiner") received a request from Intervenor TreePAC for electronic copies of exhibits entered during the hearing on the merits and the transcript of the proceedings. The Examiner hereby enters the following order:

1. The City is **ORDERED** to provide Exhibits 31, 32, 34, 35, 41, and 42 named in TreePAC's request by electronic copy, if available. If only available in hard copy, then hard copy shall be provided. The City may charge reasonable copying and reproduction fees, as specified under the Public Records Act, RCW Chapter 42.56. The City shall provide these documents to TreePAC as soon as possible, and in any event no later than April 5, 2019.
2. The Appellant, Queen Anne Community Council, is **ORDERED** to provide Exhibits 16, 17, 18, 19, 20, 26, 27, 28, 29, 30, 37, 40, and 44 named in TreePAC's request by electronic copy, if available. If only available in hard copy, then hard copy shall be provided. The Appellant may charge reasonable copying and reproduction fees, similar to those permitted under the Public Records Act, RCW Chapter 42.56. The Appellant shall provide these documents to TreePAC as soon as possible, and in any event no later than April 5, 2019.
3. The question of the transcripts has not yet been clarified. If the transcripts become available to the Queen Anne Community Council as a public record, the City shall make the transcripts available to TreePAC under the same conditions as they are available to the Queen Anne Community Council.
