EMPLOYMENT HISTORY

Plan to Permit, LLC, Owner (February 2015 to present)

Design and submit applications for shoreline permits, subdivisions, mixed use developments, site plan approval for homes (new, additions), critical area permits, variances, rezones/comprehensive plan amendments, SEPA, NPDES, HPA, and 401 permits. Services also include permit and long range planning consulting to municipalities.

City of Mercer island, Principal Planner (April 2006 to February 2015)

Review zoning applications for compliance with city and state regulations pertaining to shoreline permits, subdivisions, design review, buildable lands, environmental review, variances, rezones, boundary line adjustments, buffer reductions for wetlands, watercourses, and other natural environmental features. Draft language for the Shoreline Master Program update, comprehensive plan update, and other legislative issues. Interact with elected officials, public agencies and private organizations to analyze, evaluate, and resolve policy issues and land use regulations.

Research development regulations of various cities in King and Snohomish counties, research state laws pertaining to zoning and environmental regulations, and design subdivision layouts to meet all applicable regulations. Work with cities during the application process to ensure that application submittals comply with all applicable regulations. Ensure compliance with other required land development permits, such as HPA's, NPDES, and FPA's.

City of Lynnwood, Associate Planner (December 2003 to April 2005)

Processed variances, subdivisions, project design review, boundary line adjustments, PRD's, binding site plans, and other zoning applications. Prepared and presented written, oral, and visual reports to hearing bodies, committees, community groups, and private organizations to explain city policy and the impact of planning and development on the community. Work with applicants to find solutions to permitting issues.

City of Duvall, Assistant Planner (June 2000 to December 2003)

Duties included managing zoning applications for long and short plats, site plan approval, and planning review of building permits. Drafted amendments to the zoning regulations and comprehensive plan, presentations to the Planning Commission and City Council, completed full buildable lands reports, managed salmon enhancement projects, and staff representative to salmon recovery forums.
