Appellant's Motion for a Discovery Hearing or in the Alternative, for *In Camera*Review and Ruling by the Hearing Examiner on Several Documents Claimed to Be
Excluded from Discovery by Virtue of Attorney-Client Privilege.

Discovery Status

In response to Appellant's Discovery Request, the City on February 5th and February 6th provided the Appellant with over 8,000 pages of responsive documents. A review of those documents brought to the Appellant's attention an e-mail from SDOT's Bike Share and Shared Mobility Hub (Mr. Joel Miller) thanking Assistant City Attorney Patrick Downs (and others) for assistance in preparing the SEPA submission. See Attachment A.

For reasons briefly described below, the timing and content of draft iterations of the SEPA Checklist may be probative of whether SDOT met the SEPA requirement that agencies 'shall to the fullest extent possible . . . prepare environmental documents that . . . are supported by evidence that the necessary environmental analyses have been made." SMC 25.050.030 B.

Accordingly, on February 11th, Appellant served on the City an interrogatory specifically requesting copies of any drafts of the SEPA Checklist. The Appellant also by interrogatory requested a log of any documents as to which the City was invoking a claim of Attorney-Client Privilege.

The City responded on February 19th. To the best of the Appellant's ability to absorb the voluminous production, the Appellant believes no Draft Checklists have produced. If this is mistaken, the Appellant shall be gladly corrected by counsel for the City. A six-page Privilege Log was provided claiming privilege for 42 items. See Attachment B.

On inspection of the Privilege Log, eight of the 42 items are emails that include reference to "attached draft checklist." An inference reasonably might be drawn that there are perhaps five separate "draft checklists" at issue, generally timed as implied from the following table.

PRIV001	October 1
PRIV003 and PRIV004	October 7
PRIV033	November 15
PRIV034 and PRIV035	November 19
PRIV038 and PRIV039	November 27

No claim is made of attorney work product for any of the items on the Privilege Log.

The Appellant seeks access to the "attached draft checklists" impliedly identified above. To the extent that the emails standing alone without the attachments would properly be subject to the privilege, there is no request for the production of the emails. Just the Draft Checklists suitably identified to place them in the chronology of events.

The materiality of this evidence.

Based on the review of a considerable documentary record, the Appellant can aver that the evidence produced at the hearing will show:

- A SEPA process at SDOT was underway with respect to some version of a Scooter Share Program and SMC amendments, at least as early as sometime in early-October.
- For at least two absolutely central features of the Scooter Share Program that should have been subject to an identification and evaluation of potential significant adverse environmental impacts, the City made major mid-course revisions to the emergent proposal:
 - O Sometime between October 24th and November 20th, the scale of the emergent proposal was increased from 10,000 shared e-scooter devices to up to 20.000 shred e-scooter devices (triggering identification and analysis of impacts on Elements of the Built Environment specifically "B.3 (a) (e), Transportation" and "B.4. (a), (b), (d) and (i health services), Public Services and Utilities."
 - On or about November 13th November 15th, a complete overhaul and major revision was made for the delineation within the right-of-way (including sidewalks and streets throughout the entire city) where shared e-scooter riding as well as riding of privately owned motorized stand-up electric scooters would be allowed and disallowed (same required elements of impact identification and assessment as above).
- On November 12th, Mayor's Office responsible liaison with SDOT on the scooter share program emailed two senior members of the Mayr's staff, writing:

"We have to make some decisions this week re: scooter share pilot program for the SEPA review." (Attachment C, emphasis supplied for convenience of reference).

- Between November 19th and November 21st an email thread (Attachment D, emphasis supplied for convenience of reference) demonstrates that internal activity at SDOT was seeking fresh attention to "the SEPA inputs summary."
- On or about November 25th, SDOT met with the Mayor or senior members of her staff with a stated objective (if properly elicited from the Draft of a PowerPoint presentation apparently prepared for such a briefing) of receiving "Feedback and Guidance on these two topics:" (Slide 17)
 - "Based on permit conditions and management expectations, what is desirable number of devices?"
 - o "What is the maximum number of devices to permit to launch?"

And noted "Upcoming Actions:" (Slide 18)

o "SEPA Review"

The Cover Page and Slides 17 and 18 of the PowerPoint are attached as Exhibit E. The Appellant must acknowledge in view of the large volume of documents produced, that if a materially superseded version of this Drat PowerPoint was used in the presentation to the Mayors' Office, it has not been located by the Appellant after diligent effort, and the Appellant would be appreciative of attention being promptly drawn to a superseded or non "Draft" document.

 On December 2nd, the first business day after the intervening Thanksgiving Holiday, the DNS ad SEPA Checklist were signed.

The "attached draft checklists" (or any of them) identified in the table above, may illuminate whether SDOT failed to conduct even a *prima facie* identification and evaluation of impacts for the Proposal that led to the Determination on Non-Significance for SEPA purposes. This argues for their careful scrutiny for claimed protection of the privilege that may shroud what the Draft Checklists will show.

Further, if the all drafts of the Checklist *are* subject to the Attorney-Client Privilege, any testimony of City witnesses as to matters contained within them may constitute a waiver of the privilege at the hearing – a most awkward situation that should be avoided if possible.

Relief requested in this motion.

- 1. A hearing to test the claims of Attorney-Client Privilege on the "draft attached checklists" impliedly described in the above table. Cumbersome. Problematic in light of the tight deadline for exchange of exhibit lists (Monday, March 2nd). Probably not the most practical and efficacious course to a prompt resolution of the appeal. Alternatively:
- 2. The "draft checklists" at issue should be submitted for inspection in camera to the Hearing Examiner for ruling on the application of the privilege. The Appellant would appreciate that submission of the documents in camera would be accompanied by a complete identification of the documents in question (for example, whether or not labeled as "privileged "and the substance of any submittal by counsel to the City as to the applicability of the privilege and full verification that no use of the documents has been made in a non-privileged setting that would constitute a waiver of the privilege for the draft checklists, even if not the transmittal emails.

The Appellant requests that if any resolution of Attorney-Client Privilege claims is made in favor of production of one or more documents, provision be made for any necessary amendment of the Exhibit List timely following the March 2nd deadline. As to any document to which the Attorney-Client Privilege survives *in camera* review, the Appellant requests that copies of the document accompany the City to the hearing in case issues of waiver should arise at hearing.
