On **September 14, 2024**, the Director, as authorized by SMC 23.91.002, served a Notice of Citation to **Cornerstone GC, Inc** for violation of the provisions of the Seattle Municipal Code pertaining to:

- **Noise (SMC 25.08.410 and .425A.1.)**

Having failed to file a response to the notice of citation within 15 days of service, **Cornerstone GC, Inc** is found to have committed the violation and **must pay the standard penalty of \$150.00**, as required by SMC 23.91.016.
