**MITIGATION  
HEARING  
DECISION**

On October 23, 2024, the Director, Seattle Department of Transportation (SDOT), as authorized by SMC 15.91.004, served a Notice of Citation, assessing a **\$1000.00** penalty to **James Otis Moore** for violation of the provisions of the Seattle Municipal Code pertaining to:

- **No permit obtained (SMC 15.04.010)**

**James Otis Moore** requested a hearing to mitigate the violation. That hearing was held on December 19, 2024. At the time of the hearing, SDOT records indicated that the conditions giving rise to the issuance of the citation **had** been corrected.

DECISION

As provided by SMC 15.91.010, **James Otis Moore** is found to have committed the violation alleged in the citation.

The evidence presented at hearing supports the request that the penalty be reduced because:

The violation was caused by the act, neglect, or abuse of another.

or

Correction was commenced promptly prior to citation, but full compliance was not achieved due to challenges by the appellant with the City permitting system.

OR

The evidence presented at hearing does not support the request that the penalty be reduced.

OR

The Appellant failed to appear at the hearing. The appeal is dismissed by order of default,

in accordance with Hearing Examiner Rule 3.14.

PENALTY

On the basis of the above, **James Otis Moore** is assessed **\$150.00** which is now due and payable.
