**ORDER OF DEFAULT:
FAILURE TO RESPOND
FINDING OF VIOLATION
IMPOSITION OF PENALTY**

On **January 3, 2025**, the Director, as authorized by SMC 22.600.020, served a Citation to **Encore LLLP / Encore at Belltown** for violation of the provisions of the Seattle Fire Code pertaining to:

- Inspection, testing and maintenance of fire protection systems and radio enhancement systems not being completed (18 SFC 510.6, 18 SFC 901.6, SFD Administrative Rule 9.02)

Having failed to file a response to the notice of citation within 15 days of service, **Encore LLLP / Encore at Belltown** is found to have committed the violation and **must pay the standard penalty of \$746.00**, as required by SFC 112.4.3.

If payment (via check, money order, or credit/debit card (Visa and MasterCard only)) of the penalty for **\$746.00** has not been received at the address noted below within 15 days of the date of this Order, the outstanding penalty will be referred to a collection agency and the costs of collection will be added to the penalty. Make checks or money orders payable to the "City of Seattle." Credit/debit cards are accepted over the phone. Checks are accepted in person or through mail.
