**AMENDED
PREHEARING ORDER**

A prehearing conference was held in this matter on April 27, 2015. The appellants in the appeals of the Director's SEPA determination of EIS adequacy were represented as follows: Washington Community Action Network ("Washington CAN"), by Claudia M. Newman; 19th Avenue Block Watch/Squire Park Neighbors ("BlockWatch"), by Vicky Schiantarelli; Cherry Hill Community Council ("Cherry Hill"), by Mary Pat DiLeva; Squire Park Community Council ("Squire Park"), by Bill Zosel; and Concerned Neighbors of Swedish Cherry Hill ("Concerned Neighbors"), by Troy Meyers. Patrick Angus, Maja Hadlock, Dean Paton, James Schell, and Nicholas Richter ("Patrick Angus, et al.") did not have a representative in attendance. The applicant, Swedish Medical Center Cherry Hill ("Swedish"), was represented by Joseph Brogan, attorney-at-law. Sabey Corporation ("Sabey"), the owner of part of the Swedish Medical Center Cherry Hill campus property, was represented by John C. McCullough, attorney-at-law. The Director, Department of Planning and Development ("Director" or "Department") was represented by Stephanie Haines, Land Use Manager.

The parties discussed the need for clarification of the issues in Washington CAN's appeal and gave an estimate of the number of witnesses each expects to call. Swedish, Sabey and the Department agreed that they may be filing dispositive motions concerning issues raised in the SEPA appeals ~~that relate only to the Swedish Major Institution Master Plan~~

~~(MIMP) and not to the EIS.~~ The Examiner discussed the expected order of presentation in the consolidated hearing and the expected dates for written closing arguments.

To the extent that the SEPA Appellants, or any expert witnesses they expect to call, wish to testify concerning the MIMP, they may do so during the public testimony portion of the hearing. However, that testimony may not be repeated during the portion of the hearing devoted to the SEPA appeals.

| May 5, 2015 | Washington CAN shall file and serve any clarifications required to its "Statement of Issues on Appeal" in light of the content of the July 3, 2014 letter attached to the appeal. |
| May 8, 2015 | Swedish, Sabey and the Director shall file and serve any dispositive motions concerning the SEPA appeals. |
| May 15, 2015 | Any appellant responding to any dispositive motions must file the response with the Office of Hearing Examiner and serve a copy on all other parties by this date. |
| May 19, 2015 | Swedish, Sabey and the Director shall file and serve any replies on the dispositive motions. |
| June 12, 2015 | All parties shall file their final witness ¹ and exhibit lists with the Office of Hearing Examiner and serve them on all other parties. The parties shall also exchange among themselves copies of the exhibits included on the exhibit lists. |

¹Witness lists must include the names of witnesses and a brief summary of their expected testimony. If a witness will be testifying as an expert, a statement of qualifications must be included. Except for purposes of impeachment or rebuttal, only those witnesses and exhibits listed by the parties may be offered during the SEPA appeal portion of the hearing.

The parties are reminded that Hearing Examiner Rule (HER) 2.05(a) requires that any electronically filed document more than 10 pages in length, including exhibits, must also be delivered to the Hearing Examiner in hard copy; and HER 2.05(c) prohibits the filing of more than 15 pages with the Office of Hearing Examiner by electronic facsimile.

- Appellants' presentation of evidence
- Department's presentations of evidence
- Swedish's/Sabey's presentations of evidence
- Opportunity for rebuttal by all parties

The Appellants may agree among themselves upon an order of presentation or the Examiner will establish one at the hearing. The Department and Swedish/Sabey may also agree upon a different order of presentation than the ones listed above.


