The Department of Finance and Administrative Services (FAS) objects to the August 14, 2025 consolidation order for Citations AHNL-25-07-001 and AHNL-25-07-002. Although both citations are

issued to the same party, the incidents occurred on different days, involve different witnesses and exhibits, and are scheduled for two different hearing types.

PNWSODO LLC requested a mitigation hearing for citation 001 but submitted a request to convert the mitigation hearing to a contested hearing.
