**ORDER OF DEFAULT
FAILURE TO RESPOND
FINDING OF VIOLATION
IMPOSITION OF PENALTY**

This matter involves property addressed as **814 S Lane St.**, Seattle, WA.

On **July 24, 2025**, the Director, as authorized by SMC 10.10.030(B), served a Citation to **Lidiya Yemane / King Lounge / Caravel Lounge LLC** *for violation of the provisions of the Seattle Municipal Code pertaining to:*

- **Operating without a valid liquor license with extended hours added activity (SMC 10.10.020)**
- **AHNL failed to submit a written safety plan that meets the requirements of this section (SMC 10.10.020)**

Having failed to file a response to the notice of citation within 15 days of service, **Lidiya Yemane / King Lounge / Caravel Lounge LLC** is found to have committed the violation and **must pay the standard penalty of \$1000.00**, as required by SMC 10.10.030(D).

If payment (via check or money order only) of the penalty for **\$1000.00** has not been received at the address noted below within 15 days of the date of this Order, the outstanding penalty will be referred to a collection agency and the costs of collection will be added to the penalty. Make checks or money orders payable to the "City of Seattle." Checks are accepted in person or through mail.
