Dear Madam Examiner:

This is to confirm withdrawal of the June 12, 2015 request to amend the case schedule for this appeal as established in the Prehearing Order of May 19, 2015. I have confirmed this with new counsel for appellant, Ms. Julie Nicoll.

Verizon Wireless' agreement to amend the case schedule was for the purpose of accommodating Ms. Nicoll and was expressly contingent on the availability of an August 24, 2015 hearing date. Since that hearing date is no longer available, the parties wish to continue with the existing case schedule and hearing date of July 22, 2015 in the Prehearing Order of May 19, 2015. 
