On **December 9, 2025**, the Director, as authorized by SMC 23.91.002, served a Notice of Citation to **D Ellsworth III** *for violation of the provisions of the Seattle Municipal Code pertaining to:*

- **Weeds and Vegetation (SMC 10.52)**

Having failed to file a response to the notice of citation within 15 days of service, **D Ellsworth III** is found to have committed the violation and **must pay the standard penalty of \$150.00**, as required by SMC 23.91.016.
