On **December 9, 2025**, the Director, as authorized by SMC 23.91.002, served a Notice of Citation to **Stephen Peters** for *violation of the provisions of the Seattle Municipal Code pertaining to:*

• **Weeds and Vegetation (SMC 10.52)**

Having failed to file a response to the notice of citation within 15 days of service, **Stephen Peters** is found to have committed the violation and **must pay the standard penalty of \$150.00**, as required by SMC 23.91.016.

If payment (via check, money order, or credit/debit card (Visa and MasterCard only)) of the penalty for **\$150.00** has not been received at the address noted below within 15 days of the date of this Order, the outstanding penalty will be referred to a collection agency and the costs of collection will be added to the penalty.
