
Scheduling matters were discussed at the conference, and the schedule for this case is as follows:

| July 29, 2016 | The Examiner expects to issue an order on the motion to dismiss by this date. |
| August 18, 2016 | The Appellant shall file its witness ¹ and exhibit lists and serve them, together with a copy of each exhibit, on OPCD. |
| August 25, 2016 | OPCD shall file its witness ¹ and exhibit lists and serve them, together with a copy of each exhibit, on the Appellant. |
| August 31, 2016 | Hearing on the merits of the appeal at <u>9:00 a.m.</u> The afternoon of September 1, 2016, has also been reserved on the calendar for continuation of the hearing. |

¹Witness lists must include the names of witnesses, a brief summary of their expected testimony, and the approximate amount of time required for the testimony. If a witness will be testifying as an expert, a statement of qualifications must be included. Except for

purposes of impeachment or rebuttal, only those witnesses and exhibits listed by the parties may be offered at the hearing.
