In an email to me yesterday, Mr. Lell, the City's attorney, suggested that we are responsible to subpoena the witnesses provided on our Witness list provided last Monday. This seems unnecessary because all the witnesses are either City Staff or consultants and we thought that the City would agree to provide said witnesses.

We are willing to do what the City asks, so we request that you approve the attached 16 subpoenas regarding our group's appeal of the City Comprehensive Plan EIS. We reduced the number that were on our witness list submitted last Monday and intend to work with Mr. Lell to reduce the number further, if the City can convince us that some of the testimony will be redundant.
