4. Matt Hutchins

Mr. Hutchins is a registered architect in Washington. He graduated with Honors from the University of Colorado, and Distinction from Arizona State University. He has taught design at the University of Washington and Arizona State University. Matt is an expert in residential design, with a specialty in small houses. Matt's resume is attached to this witness and exhibit list. He pushed for the original DADU ordinance. His Widner Cottage, an early DADU completed in 2011, won Fine Home Building's Small House of the Year, and AIA Seattle's Home of the Month. His firm, CAST Architecture, has completed many DADUs and has four Seattle cottages currently either in design, permitting, or construction. He is a former board member of Groundswell NW, a non-profit working to create more habitat and park space in Seattle. Matt lives in West Seattle. He will be called to testify on the analysis of the proposal's impacts on land use, housing, urban design, and aesthetics.

5. John Shaw

Mr. Shaw is a Strategic Advisor with the City of Seattle Department of Construction and Inspections (SDCI). Mr. Shaw analyzes transportation impacts related to project-level and programmatic proposals. Mr. Shaw will be called to testify on the analysis of the proposal's likely impacts on transportation and parking.

6. Eric Jenkins

Mr. Jenkins is a manager with the Code Compliance division of the Seattle Department of Construction and Inspections (SDCI). He will be called to testify on the proposal's likely environmental impacts based on complaints received about ADUs and DADUs in recent years.

7. Any additional witnesses necessary to rebut those offered by the Appellant or any other party.


