Denial of Application for the Marijuana Business License

### Dear Applicant,

The purpose of this letter is to provide written notification that Seattle Finance and Administrative Services (FAS) has denied Alki Herbal LLC's ("applicant") application for the Seattle Marijuana Business License under Seattle Municipal Code (SMC) 6.500.

The applicant has been denied a Seattle Marijuana Business License due to an incomplete application. SMC 6.500.050 E1. Failure to provide complete information required on an application form approved by the Director shall render the application incomplete and the license consequently shall be denied.

#### Summary of Relevant Facts

A Marijuana Business License Application for Alki Herbal LLC was received by FAS on November 29, 2016, the application was reviewed and it was determined that Alki Herbal LLC did not include a copy of the State of Washington license to operate as a marijuana business and the state's website indicated the licenses were "On Hold", a copy of the Certificate of Occupancy for correct use nor SDCI permit copies for correct use. Alki Herbal LLC was notified by email December 5, 2016 of the missing documentation.

As of January 5, 2017, a current copy of the State of Washington license to operate as a marijuana business and a copy of the Certificate of Occupancy for correct use or SDCI permit copies for correct use <u>are still</u> <u>outstanding and the application is incomplete</u>.

#### Authority and Decision

SMC 6.500.090(A)(1) provides that the FAS Director shall deny a license if the applicant does not meet the requirements of Chapter 6.500. SMC 6.500.050 E1. Failure to provide complete information required on an

application form approved by the Director shall render the application incomplete and the license consequently shall be denied.

The applicant's Seattle Marijuana Business license application is denied as allowed by SMC 6.500.090 as the application does not meet the requirements of this Chapter 6.500.

# Appeal

SMC 6.02.250 provides that any applicant whose application is denied may, within ten (10) days after mailing of notice, request in writing a hearing to contest the denial. If no request for hearing is received within the time specified, the Director's decision shall be final.
