PREHEARING ORDER

**Public testimony will be taken until 5:00 p.m. on the first day of the hearing, December 8, 2017. Public testimony will also be taken at 9:00 a.m. and 1:30 p.m. on each subsequent day of the hearing.

Cross Examination

As a general rule, the parties may ask questions of members of the public who testify only as needed to clarify their comments. However, if a member of the public testifies as an expert, reasonable cross examination by the parties may be allowed, at the discretion of the Hearing Examiner. If cross examination is allowed, the witness will then have an opportunity to make any additional comments concerning the matters covered on cross examination.


