who will provide background and context to understand the Appellant's position and perspective and  
to understand the impacts of the 5<sup>th</sup> and Virginia Proposal. He will also provide a summary of the  
permit and design review process and issues that arose during that process. Mr. Sosnowy will also  
testify about facts that are relevant to the inadequacy of environmental review of the 5<sup>th</sup> and Virginia  
Proposal and facts that are relevant to errors with the Design Review decision and process.

1 The following witnesses may testify as experts at the appeal hearing:

2 2. Ross Tilghman: Mr. Tilghman is a transportation planner and owner of the Tilghman  
3 Group, 4618 44<sup>th</sup> Avenue South, Seattle, WA. Mr. Tilghman will testify about the permit review  
4 process for the 5<sup>th</sup> and Virginia Proposal with respect to traffic, parking and alley impacts; the 5<sup>th</sup> and  
5 Virginia proposal's traffic, parking, and alley impacts; analysis and review by the City of Seattle of  
6 downtown alley impacts; cumulative traffic, parking and alley impacts caused by the Proposal and  
7 other projects in the area; and other topics that were set forth in letters that he prepared and submitted  
8 during the review process. The Curriculum Vitae of Ross Tilghman is included as an exhibit on the  
9 exhibit list below.

11 3. Joel Loveland, Loveland Building Science, 2144 East Third Street, Tucson, AZ. Mr.  
12 Loveland is architect with a particular expertise in daylighting analysis and design. Mr. Loveland will  
13 testify regarding the proposal's height, bulk, and scale impacts and health impacts associated with  
14 blocking Escala residents' access to daylight. He will also discuss mitigation of those impacts. The  
15 Biological Abstract for Mr. Loveland is included as an exhibit on the exhibit list below.

17 4. Mariana G. Figueiro or Mark Rea, Rensselaer Polytech Institute, Troy, New York.  
18 Either Ms. Figueiro or Mr. Rea will testify regarding the proposal's height, bulk, and scale impacts  
19 and health impacts associated with blocking Escala residents' access to daylight. Ms. Figueiro, Ph.D,  
20 is Director of the Lighting Research Center (LRC) and Professor of Architecture at Rensselaer  
21 Polytechnic Institute. She has also served as Light and Health Program Director at the LRC since  
22 1999. Dr. Figueiro is well known for her research on the effects of light on human health, circadian  
23 photobiology, and lighting for older adults. Mark S. Rea, Ph.D., is Professor of Architecture and  
24 Cognitive Sciences at the Lighting Research Center (LRC) at Rensselaer Polytechnic Institute. He  
25 served as LRC Director from 1988 to 2017. Dr. Rea is well known for his research in circadian  
26

1 photobiology, mesopic vision, psychological responses to light, lighting engineering, and visual  
2 performance.

3 Appellant reserves the right to call any witness identified by any other party, to call additional  
4 rebuttal witnesses, to call additional witnesses to the extent that it is allowed by the City of Seattle  
5 Hearing Examiner Rules, and to call substitute witnesses if any of the witnesses identified above  
6 become unavailable.

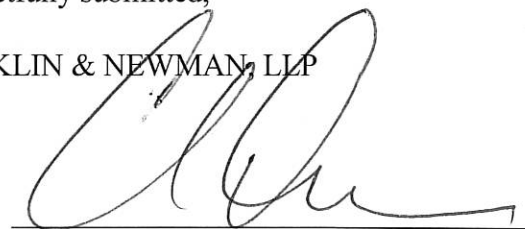
