Appellant Friends of North Rainier Neighborhood Plan (“FNR”) hereby submits its  
Supplemented Preliminary Witness and Exhibit List for its appeal.

**I. WITNESS LIST**

Appellant may call the following witnesses to testify at the appeal hearing. The general  
subject matter of their expected testimony is noted below.

1. Spencer Howard, Northwest Vernacular ([www.nwvhp.com](http://www.nwvhp.com)). (45 minutes). Mr. Howard  
may be called to testify on the City’s historic and cultural resources, including the Mount  
Baker Park Addition near the North Rainier Urban Village, and the extent to which the  
City failed to adequately analyze those resources in the FEIS and failed to consider

1 alternatives that would reduce harm to these resources. Mr. Howard is a Historic  
2 Preservationist, who co-founded Northwest Vernacular, Inc., in 2017, after spending 14  
3 years as a partner at Artifacts Consulting, Inc. Mr. Howard has a MS in Historic  
4 Preservation from the University of Oregon (2001), with a concentration in preservation  
5 technology and design. He also has a BA in German and Spanish from the University of  
6 Oregon (1999).

7 2. Maria Batayola, Owner of Jump Start (organizational development services). (45 minutes).

8 Ms. Batayola has B.A. in Political Science and in Theatre from the University of  
9 Washington, and an M.A. from City University LIOS. Ms. Batayola maintains a family  
10 home in the Beacon Hill community, where she resided for decades. She has remained  
11 active in Beacon Hill and the surrounding community through volunteer, community  
12 development and environmental justice activities, including the Filipino Community  
13 Center, the Beacon Hill Merchants Association, Beacon Hill Council, Seattle's Race and  
14 Social Justice Cabinet, the Community Coalition on Environmental Justice (co-founder),  
15 Asian Pacific Islander Community Candidates Forum (co-founder). She may be called as  
16 a fact witness and expert on issues relating to those portions of the FEIS which relate to  
17 environmental conditions and neighborhood planning in the Beacon Hill area,  
18 environmental justice, community health, and gentrification and displacement.

19 3. Eugenia Woo, Historic Seattle. (20 minutes) Ms. Woo is expected to testify on the City's

20 historic and cultural resources, including the issues covered in her comments on the MHA,  
21 submitted on behalf of Historic Seattle. From 2009 to present, Ms. Woo has been the  
22 Director of Preservation Services at Historic Seattle. Ms. Woo submitted a letter on behalf  
23 of Historic Seattle during the MHA draft EIS process.

- 1 4. Peter Steinbrueck, FAIA, Steinbrueck Urban Strategies (45 minutes).  
2 [www.steinbrueckurbanstrategies.com](http://www.steinbrueckurbanstrategies.com). Mr. Steinbrueck is a nationally recognized  
3 architect, urban policy expert, strategist, community planner, writer, lecturer, and speaker.  
4 Loeb Fellow, Harvard University; MA, Architecture, University of Washington; BA,  
5 Government, Bowdoin College. Mr. Steinbrueck may be called as a fact and expert  
6 witness on the adequacy of the FEIS with respect to the Comprehensive Plan and  
7 neighborhood planning processes, the failure of the FEIS to consider neighborhood plan  
8 goals and policies or alternatives consistent with neighborhood plans, and the failure of the  
9 FEIS to address important features of the North Rainier Neighborhood and its Plan.
- 10 5. Eve Keller, Resident. (25 minutes). Eve Keller is a resident of the Mount Baker  
11 neighborhood and active in community advocacy in and around the North Rainier Urban  
12 Village, and the Station Area. Ms. Keller may be called to testify on the unique  
13 conditions and challenges of living and working in the North Rainier Neighborhood,  
14 including the Station Area, and the deficiencies of the FEIS analysis of the proposed FEIS.
- 15 6. Barb Oswald, Resident and Business Owner (25 minutes). Ms. Oswald operates the  
16 Mount Baker Neighborhood Center for the Arts, and lives in the North Rainier  
17 Neighborhood. Ms. Oswald may be called to testify on the unique conditions and  
18 challenges of living and working in the North Rainier Neighborhood, including the Station  
19 Area, and the relationship of those issues to the FEIS analysis of the proposed FEIS.
- 20 7. Peg Giffels (20 minutes). 3010 S. Mount Baker Blvd, Seattle WA 98144. (206) 265  
21 0987. Ms. Giffels is a business owner and resident of the North Rainier Neighborhood  
22 and may be called to testify on the local conditions and challenges of living and working in  
23

1 the North Rainier Neighborhood, including the Station Area, and the failure of the FEIS to  
2 properly document, analyze or address those conditions and challenges.

3 8. Davidya Kasperzyk, AIA, Senior Consultant, Architecture, Urban Design and Bioregional  
4 Planning at Parametrix. (30 minutes). Mr. Kasperzyk is an architect with considerable  
5 background and expertise in the areas of open space planning, and historic resources. He may  
6 be called to testify as an expert about the inadequacy of the MHA EIS disclosure and analysis  
7 associated with open space and historic issues.

8 9. Michael James, AICP and Bus Rapid Transit Administrator, City of Phoenix. (45  
9 Minutes). Mr. James is expected to testify on the efforts to achieve the open space  
10 objectives of the North Rainier Neighborhood Plan with a neighborhood park that would  
11 bridge the urban village's open space gap; he will also testify on the proposal's impacts on  
12 public infrastructure and amenity plans for the North Rainier Urban Village. Mr. James  
13 served as the Rail and Transit Corridor Manager for the City of Seattle from February 2016  
14 until April 2017. Before that he spent approximately 3.5 years as a Strategic Adviser II for  
15 the City of Seattle. He has a BS in Landscape Architecture from Washington State  
16 University (1993) and a Masters in Urban & Regional Planning from Eastern Washington  
17 University (1995).

18 10. Jennifer Ott, Environmental Historian (45 minutes). Jennifer Ott is an accomplished  
19 historian, and currently serves as Assistant Director and Staff Historian at History Link.  
20 She is on the Steering Committee for the Volunteer Park Trust. In her nine years on the  
21 Board of the Friends of Seattle Olmsted Parks she served as President and Vice President.  
22 She has an M.A. in Environmental and Western American History from the University of  
23 Montana (1997) and a B.A. in History and Comparative History of Ideas from the

1 University of Washington (1993). Ms. Ott may be called as both a fact and expert witness  
2 on issues related to the FEIS analysis of Historic and Cultural Resources, and open space  
3 planning throughout the City, and specifically within the North Rainier Urban Village.

4 11. Bill Hart, resident and owner of Baked from the Hart (30 mins). Bill Hart is a resident and  
5 business owner in the North Rainier Urban Village. He may be called to testify about the  
6 actual conditions and challenges for residents and businesses in the immediate vicinity of  
7 the North Rainier Town Center, as related to the FEIS and its inadequate analysis of those  
8 issues and the anticipated impacts of the proposal in North Rainier.

9 12. Mark Temmel, resident and owner of Temmel Real Estate ([www.temmelre.com](http://www.temmelre.com)) (20  
10 Minutes). Mark Temmel is a resident and small business owner in the North Rainier  
11 Neighborhood, with expertise in commercial real estate. He may be called to testify about  
12 the actual conditions and challenges for residents and businesses in the immediate vicinity  
13 of the North Rainier Town Center, as related to the FEIS and its inadequate analysis of  
14 those issues and the anticipated impacts of the proposal in North Rainier.

15 13. Michael Ross (45 minutes). ([www.rladvisors.com](http://www.rladvisors.com)). Mr. Ross is an owner and developer  
16 in the North Rainier Urban Village with experience and expertise in real estate  
17 development, finance and land use issues. He may be called as an expert and fact witness  
18 to testify on the actual real estate and socio-economic conditions of the North Rainier  
19 Urban Village and the Mount Baker station area, as related to the FEIS and its inadequate  
20 analysis of those issues and the anticipated impacts of the proposal in North Rainier.

21 14. Rick McLaughlin, Owner Big Time Brewery. (20 Minutes). Mr. McLaughlin is a Seattle  
22 resident who has knowledge and expertise of small business conditions and the impact of the  
23 City's proposal. He may be called as a fact or expert witness to testify about inadequate

1 analysis of the FEIS with respect to socioeconomic conditions, and the related impacts and  
2 mitigation related to the proposal.

3 15. Geoff Wentlandt, Senior Planner. (45 minutes). Mr. Wentlandt has been directly  
4 involved in the City's discovery responses and in the development of the proposal and the  
5 FEIS. He may be called to testify regarding the various issues identified by FNR with  
6 respect to the FEIS and the proposal, including the failure of the FEIS to properly address  
7 important features, issues and challenges previously identified in the North Rainier Urban  
8 Village.

9 16. Lyle Bicknell, City Planner. (45 minutes). Mr. Bicknell has been directly involved in the  
10 City's discovery responses and planning processes relating to the North Rainier Urban  
11 Village, including proposed zoning changes to the Mount Baker Town Center (also known  
12 as North Rainier Town Center). He may be called to testify regarding his knowledge of  
13 the North Rainier Urban Village and its relationship to the proposal and the FEIS.

14 17. Stephen Shain, TOD Planner. (25 minutes). Mr. Shain has been tasked by the City with  
15 exploring opportunities to create positive transit oriented development in urban villages,  
16 including the North Rainier Urban Village. He may be called to testify regarding the  
17 relationship of the FEIS and the MHA proposal, to the actual conditions, opportunities and  
18 efforts to create an equitable community in the North Rainier Urban Village.

19 18. Berk Consulting. (35 minutes). Representatives at Berk (including Allegra Calder)  
20 played a key role in the preparation of the FEIS on behalf of the City, and they may be  
21 called to testify regarding the process and substance of the work product in relationship to  
22 the issues on appeal, including the failure of the FEIS to properly address critical issues,  
23 conditions and challenges in the North Rainier Urban Village.

1 19. John Le. (15 minutes). Father of a preschooler at the Hao Mai Preschool, adjacent to the  
2 Mount Baker Link Station. He may be called to testify on the open space needs in and around  
3 the North Rainier Town Center and station area.

4 20. Chris Brumfield. (25 minutes). Mr. Brumfield and his family are residents who live in  
5 North Rainier Valley, and he has been involved in the review and comment processes for  
6 the City’s proposal, as it relates to the North Rainier Urban Village and surrounding areas.  
7 He may be called to testify about the FEIS and its failure to address important features,  
8 issues, conditions and challenges in the North Rainier Urban Village as they relate to the  
9 MHA and its FEIS.

10 21. Representatives of the Respondent who may be designated as having knowledge of the  
11 issues relevant to this appeal, including but not limited to Chip Nevins, Acquisition  
12 Planner at City of Seattle, Department of Parks & Recreation (30 minutes). Mr. Nevins  
13 may be called to testify on the FEIS’s failure to acknowledge or assess the open space gap  
14 and park conditions and planning efforts within the North Rainier Town Center.

15 Appellant reserves the right to call any witness identified by Respondent or another party, to  
16 call additional rebuttal witnesses, to call additional witnesses to the extent that it is allowed by the  
17 City of Seattle Hearing Examiner Rules, and to call substitute witnesses if any of the witnesses  
18 identified above become unavailable.

19 responses or specifications of the documents that pertain to each Request For Production. Appellant  
20 requires additional time to review this voluminous discovery, which may lead to the identification of  
21 additional witnesses and exhibits.

22 Since Appellant FNR’s initial Preliminary List, the City has produced thousands of additional  
23 pages of documents. It has not been feasible for FNR to complete even a cursory review of the

1 documentation, and FNR respectfully reserves the right to supplement this list in a reasonably prompt  
2 manner given the volume of documentation received.
